If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. In-network preventive care, urgent care visit, outpatient mental health and chemical dependency services, and breastfeeding support, as well as in and out of network routine nursery care, prescription drugs, and breastfeeding supplies are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount.
